1. Purpose

- iii) The programs/presentations shall also familiarize the Independent Directors with their roles, rights and responsibilities;
- iv) The Company has conducted an introductory familiarization program/presentation, when a new Independent Director comes on the Board of the Company; and
- v) The Statutory Auditors of the Company have made presentation to the Board of Directors with regard to provisions of the Companies Act, 2013, SEBI (Listing Obligations and Disclosures Requirements) Regulations, 2015 and its impact on the Company. Further Statutory Auditors and Senior Management will make a presentation to the Board of Directors on regulatory changes while approving the Quarterly/yearly Financial Results.
